## YSA MEMBERSHIP 2017/18

Young Shipping Australia is non-profit organisation developed for young professionals within the Australian shipping industry. Established in 2007 and guided by committees based in New South Wales, Victoria and Queensland, YSA has provided the shipping community with educational seminars, industry updates, discussion forums, port, depot and vessel tours, plus many other social and networking events targeted at 'under 35s'.

YSA is introducing a new national membership structure this year – providing its members with more benefits, opportunities and access to a larger professional network. Effectively the change will mean a joining of YSA's existing groups in New South Wales, Victoria and Queensland to form a national group of young shipping professionals across Australia.

Membership with Young Shipping Australia is available on an annual basis (July 2016 – June 2017):

- **Full YSA Member** – eligible to employees of Shipping Australia Limited or Maritime Industry Australia Limited members – \$60 per annum
- **Associate YSA Member** – open to individuals with an interest in the Australian shipping industry (limited to 20% of total number of YSA members) – \$75 per annum

Members receive discounts to events across Australia and are given preference when attending limited capacity tours. Become part of the YSA network and join other young professionals keeping informed on developments within the shipping industry.
